Objective: Evaluate the efficacy of applying ***Liberty Ultra** first early-POST in the Enlist One soybean system

Crop: Soybean

Hybrid: O'SOY 2024EL-3

Weed species (pressure): glyphosate-resistant waterhemp
fall panicum

Herbicide Application(s): PRE – 5/24
POST – 6/27 (V3 soybean)
LPOST – 7/10 (R1 soybean)
LPOST – 7/16 (R2 soybean)

***Liberty ULTRA** is a new formulation of glufosinate (Liberty 280 SL) powered by Glu-L™ Technology offered by BASF. 24 fl oz of Liberty ULTRA is equivalent to 32 fl oz of Liberty
